

# Electric Vehicle Toll Incentive Information

The Electric Vehicle Toll Incentive (EVTI) Scheme commenced on July 1st 2018 and is expected to run until December 31st 2022.



Battery Electric Vehicles (BEV)



Plug-in Hybrid Electric Vehicles (PHEV) vehicle with CO<sub>2</sub> emissions of 80gm per km or less



- Conventional Hybrid vehicles are not covered by the scheme.
- The vehicle must be a registered vehicle in the EU.
- Goods vehicles will be eligible if they meet the above criteria and have a vehicle design gross weight not exceeding 3,500 kilogrammes.
- Small Public Service vehicles (Taxis, Hackneys and Limousines) meeting the scheme vehicle criteria will be considered as a private vehicle under this scheme with the same refunds applicable.
- Participating vehicles must have a toll tag and be registered and approved for the EVTI scheme by an EVTI toll tag provider.

## Frequently Asked Questions:

### If I have an electric vehicle am I eligible to claim my reduced toll as I drive through a toll plaza or through the M50?

No. Your vehicle needs to be registered with a participating tag provider, and your vehicle must have an electronic toll tag to avail of the reduced toll.

### Where do I get a toll tag for my vehicle?

Toll tags are available from the participating tag providers who have been approved to administrate the scheme. See [www.etoll.ie](http://www.etoll.ie).

### How do I know whether my vehicle is eligible for entry to the scheme?

Please refer to the scheme rules on eToll.ie for information on eligible vehicles. Before being allowed to participate in the scheme, the tag provider will perform several checks, which may require the customer to submit additional vehicle details as evidence that the vehicle is eligible. Please refer to your tag provider for details on evidence they may require before they accept your vehicle in to the scheme.

### Do I need to pay the fee for the toll tag?

Yes, the cost of the physical toll tag is not discounted by the scheme. Please refer to your tag provider for details on tag costs. Existing tag users with eligible vehicles can transfer their tags in to the scheme.

### How much of a refund will I be entitled to?

Please refer to the scheme rules on eToll.ie for details on the refunds available and refund caps. There is a maximum refund cap of €500 for private vehicles and €1,000 for goods vehicles per calendar year. See tables below.
